

The Transfer Stations have on site attendants available to direct the proper disposal of waste and recycling. Please assist them by properly separating and disposing of waste and recycling in the designated areas and appropriate bins.

Licencing of the Transfer Stations is dependent on proper site maintenance and everyone's cooperation will aid in keeping costs down.

The Transfer Stations are provided for the Residents and Property Owners in the RM of Cornwallis.

Waste must be separated into household, metal, woods, and tires and placed in the designated areas at the Transfer Stations.

Residents who take waste directly to the City of Brandon Landfill site will be responsible for paying the City of Brandon's landfill charges. Hours of Operation

RECYCLE

All residents are encouraged to recycle Please do not place your recyclables in a green, black or white solid bag. Unless a bag is transparent and clearly contains nothing but recyclables, the bags will be treated as garbage.

ACCEPTED RECYCLING

UNACCEPTED RECYCLING

Aluminum foil, foil pie plates or foil food containers, dishes, ceramics, electronics, foam packaging, food waste, hangers, pet food bags, single use plates & cutlery, paint cans, oil cans, paper towels, tissues or napkins, steel pots & pans, take out beverage cups, window glass, mirrors or broken glass.

OZONE DEPLETING SUBSTANCES

Appliances such as refrigerators, freezers and air conditions containing ozone depleting substances may be taken to the Municipality's Transfer Stations for disposal. The Municipality will arrange the proper removal of the Ozone Depleting Substances.

HAZARDOUS WASTE

Liquid sewage, oils, and hazardous wastes will not be accepted at the Transfer Stations. Residents are encouraged to participate in the hazardous waste collection programs sponsored by the City of Brandon and the Province of Manitoba.

DISPOSAL OF BURN BARREL RESIDUE

The disposal of residue from burning barrels is prohibited at the Municipality's Transfer Stations.

CONTRUCTION AND DEMOLITION WASTE

Construction and demolition (C & D) waste is material from the construction, remodeling, repair or demolition of buildings.

Disposal of C & D waste is prohibited at the Municipality's Transfer Stations.

C & D waste should be taken directly to Eastview Landfill site for disposal. Persons disposing of C & D waste will be responsible for paying the tipping fees.

INDUSTRIAL WASTE

Industrial waste should be taken to the Eastview Landfill site. Persons disposing of the industrial waste will be responsible for paying the City tipping fees.



COMBUSTABLE MATERIALS

The Transfer Station accepts readily combustible materials such as boughs, leaves, straw, paper products, cardboard, nonsalvageable raw wood and packaging materials for burning that are in compliance with Environmental Regulations.
