BY-LAW NO. 1719/11/2023A

A By-Law to Amend By-Law the Aggregate By-Law 1719/11/2023

WHEREAS Council passed the Aggregate By-Law 1719/11/2023 December 19th, 2023;

AND WHEREAS Municipality wishes to provide for the licensing of aggregate mining and transportation and for the licensing of the transportation of mining aggregate within the Municipality and to set fees payable in connection with such licensing;

AND WHEREAS The Aggregate Mining and Transportation Fees and Agreements Regulation (48/97) under The Municipal Act enables municipalities to pass by-laws to collect fees up to a set level from aggregate operators to offset municipal costs associated with aggregate mining;

AND WHEREAS There is an update to these fees for 2024 to reflect inflationary increases, as measured by the Consumer Price Index for Manitoba in 2023;

AND WHEREAS the Municipality must amend their existing aggregate by-law to charge the increased fees within these levels.

NOW THEREFORE the Council of the Rural Municipality of Cornwallis in Council duly assembled, enacts as follows:

1. FEES as follows:

Section 6.3.1 for a fee based on the quantity of aggregate mined in the Municipality by that person during the calendar year specified and which fee shall be the lesser of the amounts calculated in tonne or cubic metre as follows:

Section 6.3.2 for a fee for the transportation of aggregate for the shortened lifetime of and, maintenance, repair and restoration of municipal roads which fee shall be as determined by the following formula: A X B

- A is the number of kilometers of municipal road over which the aggregate is transported;
- B is the lesser of
- (a) the number of tonnes of aggregate transported, multiplied by the rate per tonne set out in the following table for the relevant time period; and
- (b) the number of cubic metres of aggregate transported, multiplied by the rate per cubic metre set out in the following table for the relevant time period.

January, February and December and following	\$0.0330	\$0.0580
