**By-law No. 1686/07/2019**

**MAXIMUM SPEED LIMITS BYLAW**

**Being a bylaw to establish the maximum speed limit on a highway or portion of a highway under the responsible traffic authority's jurisdiction.**

**WHEREAS** The Highway Traffic Act C.C.S.C., c. H60 gives a traffic authority the ability to establish a speed limit up to 90 km/h for any geographic area, highway, or portion of a highway for which it is the responsible traffic authority;

**AND WHEREAS** section 6 of the Traffic Authority Speed Limits Regulation provides that a bylaw traffic authority must:

- (a) Describe any portions of highway to which the speed limit applies, either by reference to a specific highway and the points on the highway at which the speed limit begins and ends or by reference to the boundaries of a geographic area.
- (b) Indicate whether the speed limit applies at all times or applies seasonally.
- (c) If the speed limit applies seasonally, indicate the day that the speed limit starts and the day that it ends in each year.
- (d) Be accessible to the public.

**AND WHEREAS** Council for The Rural Municipality of Cornwallis deems it advisable and in the public interest to fix a speed limit for the highways or portions of highways, for which the Rural Municipality of Cornwallis has jurisdiction;

**NOW THEREFORE** the Council of The Rural Municipality of Cornwallis enacts as follows:

**Maximum Speed Limits on Highways within The Rural Municipality of Cornwallis**

At all times of the year, the maximum speed limit on highways under The Rural Municipality of Cornwallis jurisdiction is as prescribed in the Schedule A that is attached and forms part of this bylaw.

**Chater**- All those highways and portions of highways situated in the R.M. of Cornwallis in the community of Chater that are within the boundaries of the NE ¼ 27-10-18 WPM 50 km/h

**Cottonwood Acres** – All those highways and portions of highways situated in the R.M. of Cornwallis in the community of Cottonwood Acres excluding P.R. No.340 and the Road Allowances lying adjacent to section 22-10-17 WPM lying within said section 22. 50 km/h

**Hoops Loop** – That portion of Hoops Loop situated in the R.M. of Cornwallis That is within section 13-10-17 WPM and the north of the northern boundary Of Road 56 N 50 km/h

**Gray Subdivision** – All those highways and portions of highways situated in the R.M. of Cornwallis that are within the Gray Subdivision within the E ½ of Section 30-10-19 WPM 50 km/h

**Sprucewoods** – All those highways and portions of highways situated in the R.M. of Cornwallis in the community of Sprucewoods that are within the Boundaries of the E ½ 12-10-17 WPM 50 km/h

**Patricia Avenue** – That portion of Patricia Avenue situated in the R.M. of Cornwallis lying adjacent to the southern boundary of the City of Brandon lying between the point where the western boundary of 1<sup>st</sup> Street or the production thereof crosses the highway and the point where the eastern boundary of 9<sup>th</sup> Street or the production thereof crosses the highway 60 km/h
