I would like to thank the former police board chair Mike Waddell for his diligent work in leading the board forward and strengthening the relationship between the Board, Constable Drader and CAO Donna Anderson.

On November 22, 2018 Constable Drader received the Governor General of Canada - Police Exemplary Service Medal for both 20 years and 30 years of Service. This was awarded at the Association of Chiefs of Police annual Gala in Winnipeg. I extend my congratulations and the boards to Chief Constable Drader. We are proud to have him as employee on the police force.

2018 saw the deployment of a portable radar traffic speed and safety sign unit. The unit was deployed on traffic hot spots on roads in the R.M. The radar speed sign was purchased by the RM of Cornwallis with the assistance of a grant received through a Criminal Property Forfeiture Grant application.

Moving ahead into 2019 holds great promise with the potential of further equipment upgrades.
